The budget for mulch was set at \$10,000 and these proposals are under the budgeted amount.

# **Violation Variance**

An upcoming new owner asked the BOD to extend 6+ months time to correct current violations in a home they are purchasing. The home has been in violation for over 2 years. The current owners and proposed new owners were made aware of the property deficiencies prior to the contract during disclosure.

Mark Mrozik made a motion to allow the new owners 60 days from closing to correct the 2 outstanding violations before the HOA will begin levying fines. Motion 2<sup>nd</sup> by Casey

The new secretary for the BOD will make sure the property manager and the current owners are informed of the BOD decision.

#### **Outstanding Balances**

There are currently 14 owners with outstanding balances. Of the 14, 11 are owner residents, out of a total of approx. 50 owner residents.

Mark Mrozik made a motion to begin charging all owners of Stone Creek the maximum allotted 1.5% per month interest for accounts outstanding. Motion 2<sup>nd</sup> by Casey

That the Rules and Regulations be amended to include: multiple lot owners or multiple owners of one lot may not hold more then one seat on the BOD. Motion  $2^{nd}$  by Casey
