# I. Garbage Can Amendment

A motion was made by Laura Blakely and Deborah Wolf 2nd the motion.

Trash receptacles can be stored, kept, or maintained within the dwelling unit, garage or on the side of the house on each of the lots, except on such days as trash, garbage, or other waste material is to be collected and removed. If the garbage cans are placed on the side of the house, they cannot be visible from the street or from the street sidewalk. The homeowner has the right to landscape around the trash receptacles to hide them from view or build a wall. If you plan to build a permanent structure, you must fill out the application for modification and receive approval from the HOA before beginning the project.
